10.12 DOG AND LITTER BIN EMPTING BY MSDC

The Chairman reported that as from 1st April 2012 MSDC will be introducing charges for the emptying of all dog and litter bins within the village. It will cost £10 per litter bin per year and £15 per dog bin per year. The Parish Council's street cleaners informed the Council that they already emptied the litter bins within the village as part of their contract but would empty the dog bins at £10 per bin per year. It was agreed that the street cleaners empty the dog bins from 1st April 2012 at £10 per bin per year.
